# ENERGY ASSISTANCE VICTORIA

Families and small businesses in Victoria are doing it tough right now, with energy prices skyrocketing under Labor. Household electricity costs have risen nearly 8 per cent, and gas costs by nearly 36 per cent over the last year, with further power price rises for Victorian households of up to 25 per cent, or \$352 a year, to take affect from 1 July, 2023. Meanwhile, Victorian small businesses can expect their energy bills to increase by up to 25 per cent starting this winter.

## **SPEAK TO YOUR ENERGY RETAILER**

Your energy retailer is required to provide you with assistance. Contact your retailer and ask them for help. Energy retailers must offer residential customers the option of paying your bill with a payment plan.

If you are having a tough time paying your energy bills and you miss a bill, your retailer must work with you to provide tailored assistance. Your retailer is best placed to advise how they can assist you.

## **ACCESS CONCESSIONS**

The **VIC State Government** has a number of concessions and rebates that may be available to eligible consumers. This includes annual electricity and gas concessions, and a winter gas for eligible customers.

Contact your energy retailer. They can provide further information about applying for state government concessions and relevant eligibility requirements.

In addition, the VIC Government has also created a special Power Saving Bonus one-off payment.
